



Terms of use of the EMS external website

This website is administered by the Bank for International Settlements ("BIS"). Use of this website constitutes agreement by users of this website ("Users") with the following terms.

1. Copyright

- 1.1 Except where expressly stated to the contrary, copyright and other intellectual property rights in the material and information available on this website, in the names, acronyms and logos of the BIS, and with respect to the "look and feel" of this website, are owned by the BIS. Any rights not expressly granted herein are reserved.
- 1.2 Users may download, display, print out and photocopy material posted on this website for personal reference and may draw the attention of others within their organisation to material posted on this website.
- 1.3 Some material on this website may contain references to materials from third parties, for which copyright must be honoured.

2. Privacy policy

- 2.1 The BIS may collect, store and use the following kinds of personal data:
 - information about Users' computer and Users' visits to and use of this website, such as Users' IP address, browser type, referral source, the date and time of visit and number of page views;
 - information that Users provide to the BIS for the purpose of registering with this website, such as title, name, address, organisation, gender, password, e-mail address or phone number;
