## Legend

**HLM** = high-level meetings are attended by heads of supervision to discuss topical issues.

**HvS** = high-level virtual sessions are the virtual equivalent of HLMs; typically last 120 minutes.

**OC** = online courses typically span 3-6 months and require participants to go through FSI Connect tutorials and/or other learning materials as well as webinars.

**PIM** = policy implementation meetings are attended by heads of departments/units or key technical experts within financial sector authorities to discuss specific policy or technical issues.

**RegSem** = regional seminars are attended by technical staff of financial sector authorities to learn about specific regulatory and supervisory topics.

**vMeet** = virtual meetings are the virtual equivalent of the PIM; these typically consist of one or two 90 minute sessions.

**vSem** = virtual seminars are the virtual equivalent of RegSem; these typically consist of two or three 60 minute sessions and may include prerequisite FSI Connect tutorials.

**Web** = webcasts or webinars are 45-60 minute sessions on topical regulatory or supervisory topics and open to all financial sector authorities.
