- **HLM** = high-level meetings are attended by heads of supervision to discuss topical issues.
- **OC** = online courses typically span 3-6 months and require participants to go through FSI Connect tutorials and/or other learning materials as well as webinars.
- **PIM** = policy implementation meetings are attended by heads of departments/units or key technical experts within financial sector authorities to discuss specific policy or technical issues.
- **Conf** = conferences bring together a large audience of financial sector supervisors to discuss cross-cutting issues that affect different financial sector domains (eq banking, insurance, securities).
- vSem = virtual seminars are attended by technical staff of financial sector authorities to learn about specific regulatory and supervisory topics; these typically consist of two 60-90 minute sessions and may include prerequisite FSI Connect tutorials.
- **Web =** webcasts or webinars consist of one 60-90 minute session on topical regulatory or supervisory topics and open to all financial sector
