

## Central bank total assets – data documentation

---

Last updated: 28 August 2025

The BIS central bank total assets data set tracks the evolution of central banks' balance sheets size across the world. It covers more than 50 advanced and emerging market economies. The median start year is 1942 and several series go back to the 19th century or earlier.

Data on central bank balance sheets originate from multiple sources. Financial statements or accounting balance sheets are typically the main source and are compiled in accordance with national accounting standards. The BIS-spliced series use financial statements as the primary reference. These are typically disclosed at least once per financial year for auditing purposes and have usually been published since the foundation of the central bank. This choice facilitates the backdating of the series and ensures consistency across time in terms of sources.

Yet, for some jurisdictions, higher-frequency data are only available from other sources such as the monetary presentation or statistical balance sheets. In such cases, the BIS constructed the long series by splicing the monthly or quarterly data with historical annual financial statements.

The BIS ensured consistency between monthly, quarterly and annual data by following two principles. First, whenever monthly data are available, the annual series always corresponds to the December observation, to enhance comparability across countries. Since financial statements follow the financial year, the annual BIS-spliced series may differ from the annual figures reported by those central banks whose financial year does not match the calendar year. Second, annual series are always converted from monthly data whenever they are available. Therefore, if monthly series from the monetary statistics are sourced in the absence of monthly financial statements, the annual series deviates from the annual financial statements.

To facilitate better analysis and comparisons across countries, the data set also includes series adjusted for breaks, as well as series on the total assets expressed in US dollars and as a percentage of GDP. The break-adjustment calculations follow the methodological framework specified in the *BIS Quarterly Review* published in March 2013.<sup>1</sup>

The BIS worked closely with national authorities to provide the most relevant and accurate data possible. The metadata of each series provide an extensive account of the multiple sources used to compile the BIS long series.

The BIS will update the data set once a quarter. Similarly to other BIS data sets, the central bank total assets series can be downloaded and visualised conveniently on the [Central bank total assets](#) page in the BIS Data Portal.
